The certifications issued by IMQ represent a protection for companies, constitute a useful information for the Control Authorities and, most frequently, are a requirement for participation in bids and tenders.

They are the visible guarantee of your quality, because behind each certification a well-structured qualification process verified by a third party lies. They bear witness to the "promise of transparency" made to the market at the moment in which you have decided to become certified.

It is therefore important to give visibility to the certifications achieved, reproducing the relevant marks, wherever this is required by the Regulation governing your certification, according to the criteria and the methods set out in the pages below.

# ARTICLE 1- General Rules

1.1 GRANTING THE OF USE OF TRADE MARKS As and from the date of issue of the certificate, the Concessionaire, the Organisation, the Professional figure (hereinafter "IMQ Customer") has the right to use the marks granted by IMQ (hereinafter "marks").

The marks are legally registered as collective marks; all the rights deriving from these registrations are reserved to the legal party which has registered them.

The marks are allowed to be used:

- only with reference to the single certification scheme or to the certification schemes for which the relevant certification has been achieved
- with the clear identification of the subject matter (product, organisation, competence,...) of the certification;
- in the period of validity of the certificate;
- attributing the correct meaning to the certification which the marks attest to:
- complying with the specific indications for each type of certification, as shown at article 2, 3, 4, 5 and 6 of this Regulation.

1.3 CONTROL OF THE USE OF TRADE MARKS IMQ is required to monitor the correct usage of the certification issued and relevant marks. To this end, the IMQ Customer can send the marketing department of IMQ (mkt@imq.it) a copy of the business documentation for approval prior to publication. This takes the form of catalogues, advertising tools, contracts or other forms of communication which it intends to issue to advertise the attainment of the certification.

The marks and the certification are misused if they deceive the message recipients, damage the reputation of IMQ and compromise the trust of the public, or rather when the same are not used in accordance with this Regulation.

In particular, by way of example, it is incorrect to use the IMQ Client's mark and/or certification when:

- the certification has not been issued;
- the certification has still to be issued (the requesting party CANNOT advertise the request for certification until it has been granted the relevant right to use the mark. Nevertheless, in particular cases – which must be adequately motivated – for example, participation in public tenders – IMQ may allow the requesting party to inform the interested party that the request for certification has been transmitted to IMQ);
- the certification has been revoked (or suspended, where indicated in the provision for suspension);
- the marks are matched with products/activities/services.. which are not covered by the certification;
- in the case of product mark, during the period of validity of the procedure "On-call inspections" (see "IMQ Marks – General Regulation for the Certification of products"), the IMQ Customer issues certified products on the market which have not been controlled by IMQ;
- <u>in the case of product marks</u>, if the marks are used in such a way as to be interpreted as marks of conformity to standards of organisation management systems;
- <u>in the case of a system mark, if</u> the marks are applied to test, calibration or inspection reports or certificates issued by the certified Organisation
- in the case of a system mark, if the marks are applied to products and to relevant packaging\* and/or type labels, and/or identification plates or, in any case, they are used in a way to be interpreted as indications of product conformity, including cases in which the product is represented by documents issued by the Organisation (e.g. analysis certificates, medical reports, certificates of conformity, etc.)..
- \* Packaging is a term used to describe what can be removed without the product being disintegrated or damaged. On the packages and the accompanying information, the Organization can use only one declaration regarding the possession of the Management System certification, which must include the following references: identification of the certified Organisation; type of Management System (e.g. quality, environment) and applicable standard; identification of IMQ as Certification Body.

In case of misuse, IMQ shall take all appropriate measures to stop such use, protecting its right in the most appropriate manner, including through the publication of the occurrence on its own communication media and, where necessary, on the press.

# ARTICLE 2 - Marks relating to product certification

2.1 WHERE THEY CAN BE REPRODUCED IMQ marks relating to product certification can be affixed to:

- certified products (reproduction of the mark on certified products is mandatory)
- packaging of certified products
- promotional labels of certified products
- instruction booklet and the certified product information sheet
- advertising, if the advertised product has obtained IMQ certification
- catalogues, but only in correspondence with certified products or specifying which products have obtained certification
- Internet sites corresponding to certified products
- company brochures, specifying which products the IMQ certification refers to.

2.2 WHERE THEY CANNOT BE REPRODUCED IMQ marks relating to product certification **cannot** be displayed on:

- letterheads, invoices, business cards, emails, vehicles and in any publication and communication in which it is not possible to specify which products the IMQ certification refers to
- catalogues of non-certified products even if one or more components are IMQ certified.

2.3 HOW THEY SHALL BE REPRODUCE D • **Size:** IMQ marks can be reproduced in the required size, but they must always be perfectly legible (the minimum size shall therefore NOT be less than 10 mm), without altering the proportions between bottom and height).



 COLOURS: Marks can be reproduced in colour (in the colours specified next to each mark) in black/white, in black (grey) screens, in negative.

SPECIAL REQUIREMENT FOR "PIPES": THE PRODI MARK MUST BE PLACED ALONG A GENERATOR USING THE SAME METHODS PROVIDED FOR BY THE STANDARDS FOR OTHERS OVERWRITTEN. THE MARK MUST ALSO BE SHOWN ON THE LABEL APPLIED TO EACH ORIGINAL PACKAGING OF THE MANUFACTURER. THE PRODI MARK IS ALTERNATIVE TO THE PRODIS MARK.

SPECIAL REQUIREMENT FOR "ACCESSORIES FOR PIPE SYSTEMS": THE PRD01 MARK MUST ALSO BE AFFIXED TO THE ACCESSORIES, ALWAYS ACCORDING TO WHAT IS PROVIDED FOR BY THE RELEVANT STANDARDS.

IN THE EVENT THAT THE COMPONENT IS SMALL AND ONLY IN EXCEPTIONAL CASES, THE GENERAL RULE WHICH STATES THAT PRODUCTS GRANTED USE OF THE IMQ MARK MUST BE IDENTIFIED BY THE PRESENCE OF THE PRD01 MARK CAN BE WAIVED. THIS EXCEPTION CAN ONLY BE GRANTED ON THE SPECIFIC REQUEST OF THE MANUFACTURER, WHO DOCUMENTS THE PHYSICAL IMPOSSIBILITY OF APPLYING SUCH A MARK. IN THESE CASES THE PRD01 MARK MUST STILL BE SHOWN ON THE PACKAGING OF THE COMPONENTS.

# The ICILA label only applies to management system certifications already issued under the 'ICILA' brand name

In addition to what is stated in Art. 1, 3 and 6, below we specify the particular rules that apply only to management system certifications already issued under the "ICILA" brand to which specific logos are associated with the use of the IQNet logo.



The ICILA Certification Mark can be reproduced either in colour or black and white, in a monochrome version in black or, finally, in greyscale. For colour or black-and-white reproduction, please refer to the guidelines below. For monochrome reproduction, black may be used in percentages of not less than 50%. Under no circumstances may the Certification Marks be used in colours other than those indicated.

To ensure correct legibility, the ICILA Certification Mark, in all its versions and combinations, may only be used in positive on white backgrounds. Reproduction in positive on non-white backgrounds is not permitted. Reproduction in negative is not permitted under any circumstances. In the event that the Certification Mark must be applied on a black, coloured or photographic surface, it is possible to apply a white surface underneath it to increase its legibility; this surface must extend beyond the Mark at least as far as the breathing area, i.e. an area within which no other graphic or textual elements can be inserted, which corresponds to twice the thickness of the outermost circle.



In order to guarantee the correct visibility of the ICILA Certification Mark and in particular of the standards indicated on it, the Mark may not be reproduced with a diameter of less than 20 mm. If this is not possible for reasons of bulk and proportion, the Mark may also be reproduced in a size smaller than 20 mm, with the standard(s) for which the organisation is certified, which are those indicated on the green outer circumference of the Mark itself, underneath it.





Organisations to which an accredited certificate has been issued are allowed to reproduce the ACCREDIA Mark only next to the ICILA Mark in relation to accredited schemes, while the ACCREDIA Mark is not allowed to be used without an ICILA Mark.

The ACCREDIA Mark must always be placed to the left of the ICILA Mark and cannot be reproduced with a base smaller than 10 mm. The colour ICILA Mark must be placed alongside the colour ACCREDIA Mark, in other cases it must be placed alongside the black monochrome ACCREDIA Mark.







COMBINATION **WITH CISQ** AND **IONET BRANDS** 

The ICILA mark can be combined with the marks of the CISQ (Italian Quality Systems Certification) Federation and the IQNet international network, of which IMQ is a member.

The combined ICILA-CISQ/IQNet Mark may be enlarged or reduced, maintaining the proportions, with the dimensional indications specified below. If the certified organisation intends to reproduce not only the combined ICILA-CISQ/IQNet Mark but also the ACCREDIA Mark, the latter shall always be placed to the left of the ICILA Mark, respecting the distances and proportions indicated in the ACCREDIA rules and indicated in the previous paragraph.

The ICILA Mark in colour shall be flanked by the CISQ and IQNet Marks in colour, while in other cases it shall be flanked by the CISQ and IQNet Marks as shown below. The use of the CISQ and IQNet Marks is regulated by specific Procedures, for compliance with which certified organisations are required to follow the flanking models shown below.
